

# **CAMPING CARD INTERNATIONAL (CCI) LIABILITY INSURANCE SCHEME**

## **PRODUCT INFORMATION SUMMARY**

### **Name of Insurers**

This Insurance is underwritten by Syndicate 386 @ Lloyd's, part of QBE Insurance Group, operating from One Lime Street London EC3M 7HA

### **What is Insured**

This insurance covers the CCI holders liability for damage and injury to other persons and property of others whilst camping.

### **Who is Insured (Assured)**

This covers the liability as defined above of any person travelling with the CCI holder up to a maximum of 11 people travelling in the same vehicle or groups of cyclists (not exceeding 11 persons) whilst camping with the CCI holder.

### **Features**

- Covers the Assured from the time of leaving the Assured place of residence until return
- Covers the use of a windsurfer and unpowered boats up to 5 meters in length

### **Exclusions**

This insurance does not cover claims arising through or as a result of:

Radioactive Contamination or Nuclear assemblies, war, civil war revolution rebellion and the like

Contamination through any means arising from asbestos

Damage to property owned or occupied by you

Any act with malicious intent

Any person employed by you

Any mechanically propelled vehicle

Any ship vessel or aircraft (except that described under "features " above)

Food, drink, poisoning or foreign or deleterious matter

Pollution of air, water or soil.

Skiing

Organised large scale entertainment for which an entry fee will be charged

### **Period of Insurance**

From the date of issue of the CCI until the expiry date shown thereon.

Worldwide

## **Jurisdiction**

This insurance excludes the application of the laws and any costs incurred in respect of any claim arising in Unites States of America and Canada or any territory where the Laws of the United States of America and Canada might apply

## **Cancellation**

If you feel this insurance does not suit your requirements then subject to you having paid a premium to your Club a full refund will be given within 14 days from the date of receiving the documentation as long as no claims have arisen.
